# School Meal Arrears Policy

# Introduction

Following changes instigated by Government to School Funding Formula, the Operational Services for Education Catering charging model changed from April 2014. The changes affected parts of the Arrears Procedure. These changes mean, in Trafford, schools are now responsible for their own school meal finances including any meal debt that arises. This, in turn, means schools are obliged to have a policy in place to set out terms for school meal payment and recovery of any debts which may be incurred.

The majority of our parents are supportive of all our requests for financial contributions at our school. We encourage and promote information about applications for Free School Meals.

School meals are available to pupils at a cost of £10.00 per week (subject to change - see website for current cost) or at no cost to those in receipt of a Free Meal entitlement. To enable the service to be efficiently planned the school requires advance notice of any changes to a child's meal option - if a child wishes to change meal taken the school office will need at least 1 weeks' notice.

# Payment for school meals

All parents are expected to pay for school meals unless the pupil is in receipt of a free school meal.

The payment for meals is required in advance on a weekly, monthly or half termly basis:

Broomwood Primary School use ParentPay for collection of school meals either by:-

Credit/Debit Cards Online - You will need to set up an online account Or

Pay Point Card (Ask in the office about PayPoint payments - we would only use this method as a last resort as there is a transaction fee for each use)

A full dinner money statement is available online via our ParentPay website, detailing meals taken and payments made.

We no longer take money for lunches in school unless it is a one-off for forgotten lunch or an event (e.g. Christmas Lunch)

# Forgotten Lunch

If any child on packed lunches arrives at school without a lunch, the school will try to telephone home in the first instance to establish if alternative arrangements have been made. If no alternative arrangements have been made school will provide a school meal at a cost of £2.00 which must be paid the following day to the school office.

### If payment has not been made

It is rare for parents not to make payment for meals taken, but it does happen occasionally. As a school we are responsible for the money that we hold and have a duty to limit the amount of debt owed and recover any money that is due to us. We are tightening our procedures to limit our debts; we hope that this policy will help parents/carers to manage school dinner money payments better and will ensure that all money for our children's learning is available.

### The following procedure will be followed:

If your child/children have taken school meals during the week which have not been paid for you will be sent a polite reminder (appendix 1) detailing how much you owe. This should be paid as soon as possible using your ParentPay account. If payment is not received we will send a formal letter detailing the outstanding balance and the timescale for payment (appendix 2) If we do not receive payment by the date stated we reserve the right to refuse to serve a meal to your child/children until payment is made and you will have to provide a packed lunch from home. It is your responsibility as a parent to provide a meal for your child - if you repeatedly fail to provide sufficient money to cover the cost of school meals or provide a packed lunch a referral to Social Services may be made.

The school will, in exceptional circumstances postpone the refusal to provide meals where parents have advised the school of their financial situation and school is satisfied that the funding will be forthcoming. The school will work closely with parents in working out a form of payment plan to help resolve the situation. However, where no attempt is made to clear the debt it will be forwarded to the Small Claims Court for recovery.

### **Free School Meals**

Information regarding free school meals is available from the office and Trafford Borough Council.

We encourage and remind parents to renew Free School Meals applications.
